Niranjan Guchhait, Vill-Kumarpur, P.o-Kumarpur, P.s-Bhabanipur ,Dist-Purba Medinipur was consuming electricity by the way of direct hooking from nearest L.T.O.H line dishonestly for his wrongful gain for less recording of energy to energy meter at a tune of load of 0.59 KVA, causing loss of revenue of W.B.S.E.D.C.L. During local enquiry as well as official records the fact revealed that Janmenjoy Guchhait, S/o-Lt.
