Dear Sir,

I do hereby lodged this written complaint empowered by the Electricity Act 2003 read with amendment act 2007 against one Sattar Malida, S/o-Lt. Bhaku Malida, Vill-Chakdwipa, PS- Bhabanipur, Dist-Purba Medinipur has committed theft in respect of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 11.04.2017 at about 1:15 pm I, Dibyendu Sekhar Bhunia, (DE & SL&P), Tamluk Regional office along with, Gaya Prasad Ghoroi, AE&SM, Brajalalchak CCC, Suman Kalyan Pattanayek (S.A.E) of Brajalalchak CCC, Kamal Khatua, HGSRLM, Brajalalchak CCC & other official had been to the domestic Premises of one Sattar Malida, S/o-Lt. Bhaku Malida, Vill-Chakdwipa, PS- Bhabanipur, Dist-Purba Medinipur for inspection purpose.

During inspection it was found that Sattar Malida, S/o-Lt. Bhaku Malida, Vill-Chakdwipa, PS- Bhabanipur, Dist-Purba Medinipur was consuming electricity by the way of tapping from the incoming service cable before entry to the energy meter for his wrongful gain & for less recording of energy bypassing the energy meter at a tune of load of 1.0 KVA, causing loss of revenue of W.B.S.E.D.C.L. During local enquiry as well as official records the fact revealed that Sattar Malida, S/o-Lt. Bhaku Malida, Vill-Chakdwipa, PS- Bhabanipur, Dist-Purba Medinipur is a consumer of W.B.S.E.D.C.L reference ID no-224031169 and meter no-P1344911

As the theft of electricity was detected, at first I disconnected the service connection and removed the tampered portion of the service cable and there after I seized some portion of tampered service cable (black colour 2 core pvc cable approx 2.0 mt) & one yellow colour single core pvc wire 3 mtr approx. under memo of a seizure list in presence of the witnesses as well as presence of Ahiman Bibi, W/o-Sattar Malida and their signature duly obtained on the seizure list.

The above seized articles were duly packed and labeled at the inspection site in presence of the witnesses and their signature duly obtained on the packet and label. I also prepared an inspection report at spot in presence of witnesses and Ahiman Bibi, W/o-Sattar Malida & their signature was duly obtained on it. The inspection team left the premises at 1:40pm.

Thus the accused Sattar Malida, S/o-Lt. Bhaku Malida, Vill-Chakdwipa, PS- Bhabanipur, Dist-Purba Medinipur has committed an offence u/s 135(1)(b) of electricity act 2003 read with amendment act 2007 for commission of theft in respect of electricity by way of tempering the incoming service cable before entry to the energy meter for his wrongful gain, causing loss of revenue of WBSEDCL.

On the above fact and circumstances you are requested to take cognizance and treat the same as FIR.
