Prayer for lodging a case against the arrested accused Gopal Maity (28 years) s/o Sanjib Maity of Vill Ururi, PS Bhupatinagar, Dist Purba Medinipur under proper section of law.

In producing herewith the arrested accused Gopal Maity (28 years) s/o Sanjib Maity of Vill Ururi, PS Bhupatinagar, Dist Purba Medinipur along with seized articles and all relevant papers, I beg to submit that today on 31.01.17, PSI Sanjib Adak along with forces C/ 1579 Shibnath Murmu and C/ 854 Suman Sikdar were engaged in night mobile duty vide Bhagwanpur PS GDE No.1261/17, Dated 31.01.2017 and CC No. 350, Dated 31.01.2017. In course of said duty received secret source information over the telephone from unknown caller that, a person is selling ID liquor illegally at Kishorpur to the local people in lieu of money. On receipt of this information myself along with force left for Kishorpur and being directed by O/C Bhagwanpur PS held raid at 00:15 hrs on 01.02.17 and after a hot chase able to apprehend a person duly after disclosing our identity and cause of apprehension and called witnesses C/ 1579 Shibnath Murmu and C/ 854 Suman Sikdar of Bhagwanpur PS, Dist - Purba Medinipur. On asking the apprehended person he disclosed his identity as Gopal Maity (28 years) s/o Sanjib Maity of Vill Ururi, PS Bhupatinagar, Dist Purba Medinipur and after a long interrogation able to seized (1) 05 liters Id Liquor (Cholai) containing in a plastic jar, valued approx 250/- (Two hundred fifty only) (2) 04 (Four) Plastic Glasses from the nearby place in presence of above noted independent witnesses preparing seizure list duly signed by them and the apprehended person and labeled the same maintaining all norms and formalities and the apprehended person further stated that these was stored for the purpose of selling to the local people in lieu of money. On being asked the apprehended person failed to produce any valid documents or license in respect of the seized articles. The apprehended person violated the provision of 46 A (c) of Bengal excise act 1909. As such I taken him in custody preparing Memo of Arrest and seized the noted articles issued proper seizure list which was duly signed by the witnesses after collecting sample with proper label.

Hence I pray before you for lodging a case against the aforesaid arrested accused Gopal Maity (28 years) s/o Sanjib Maity of Vill Ururi, PS Bhupatinagar, Dist Purba Medinipur under proper section of law.
