I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Sk. Muktar Hossain, S/o-Sk. Khilafat Hossain, Vill-Kumarpur, P.s-Bhabanipur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 15.12.2016 about 3:25 PM I, Gaya Prasad Ghoroi (AE & SM) of Brajalalchak CCC, along with Suman Kalyan Pattanayek, SAE(E), Sourish Mitra, O/E, Ajit Sharma, LM, Brajalalchak CCC, & Other official had been to village Kumarpur for inspection purpose & we went to the domestic premises of that Sk. Muktar Hossain, S/o-Sk. Khilafat Hossain, Vill-Kumarpur, P.s-Bhabanipur, Dist-Purba Medinipur.

During inspection it was found that Sk. Muktar Hossain, S/o-Sk. Khilafat Hossain, Vill-Kumarpur, P.s-Bhabanipur, Dist-Purba Medinipur was consuming electricity by the way of direct hooking from nearest L.T.O.H. line dishonestly for his wrongful gain at a tune of load of 0.39KVA, causing loss of revenue of W.B.S.E.D.C.L.

As the theft of electricity was detected during the inspection, the service connection was disconnected &the unauthorized wire was removed. Some portion of single core P.V.C. wire (black colour) approx 3Mt along with hooking device was seized under a memo of seizure list in the presence of witnesses and their signature is duly obtained in the seizure list. The above P.V.C. wire with hooking device was duly packed and labeled at the inspection site and signature of witnesses also obtained on the label. I also prepared an inspection report at site with duly signed by the witnesses. After completion of all formalities, we left the premises at 3:40PM.

Thus the accused Sk. Muktar Hossain, S/o-Sk. Khilafat Hossain, Vill-Kumarpur, P.s-Bhabanipur , Dist-Purba Medinipur has committed theft of energy U/S 135/(i)(a) of the Electricity Act 2003 read with Amendment act 2007 by way of direct hooking for less recording of energy to the energy meter.
