  - 3) That the said shop is main source of livelihood of the complainant and his family.
  - 4) That the said land measuring one decimal has recorded in the name of your complainant.
  - 5) That there were several materials in respect of preparing tiffin in that shop.
  - 6) That due to heavy rain the said shop was damaged.
  - 7) That while the complainant alongwith labours were repairing the said shop the accused persons came to my plot and entered into the shop broke the 4 cement pillars and destroyed the materials and took the cash box containing Rs 400/- to Rs 500/-
  - 8) That the complainant and the labours protested against the illegal act of the accused but they assulted with fist and blow and also threatened in dire consequence.
  - 9) That by the illegal activity if the accused the complainant sustained a loss of Rs 2000/- 3000/-
  - 10) That the complainant diarised the matter at P.S. being G.D. no. 170, but the C/C Bhabanipur did not take any step as a result the complainant informed to S.P. Purba Medinipur but still now no case is instituted by the authority.  
As a result the complainant is filing the case against the accused persons U/S.-448/380/323/506 I.P.C.
