In producing here with the arrested alleged person one Gandhi Jana S/o-Lt. Baranasi Jana of Chalti, P.O.- Basantia, P.S.- Contai, Dist.- Purba Medinipur with sealed 90 bottles Foreign Liquors, (i) 15 bottles Mcdowell XXX Rum contains 180 ml/bottle @ Rs/- 90 each, (ii) 35 bottles Officer Choice whiskey contains 180 ml/bottle @ Rs/- 100 each, (iii) 35 bottles Imperial Blue whiskey contains 180 ml/bottle @ Rs/-120 each, (iv) 05 bottles Imperial Blue whiskey contains 375 ml/bottle @ Rs/-235 each, Total Value Rs.=10,225/-

I, SI Partha Biswas, presently posted at Contai Ps. 30 here by lodged a written complaint to the effect that today (10.02.17) in course of my special raid duty with C/1084 Dasarath Hembron & C/1648 Haripada Mahanty under Ps. area, at about 14:45 hrs. I received a telephonic information from my reliable sources that one person namely Gandhi Jana S/o- Lt. Baranasi Jana of Chalti, P.O. Basantia, P.S.- Contai, Dist.- Purba Medinipur is selling liquors illegally from his house at Chalti under Contai Ps. since long time.

Accordingly myself along with force reached at Chalti under Contai Ps. at the house of alleged Gandhi Jana at about 15:25 hrs. and found that said Gandhi Jana is selling liquors from there illegally. Seeing Police Personnel said Gandhi Jana was tried to fled away from the spot but we caught him red-handed. On being asked, he could not produce any ralid documents in favor of those liquors. There after I seized the above not disealed 90 bottles Foreign Liquours (i) 15 bottles Mcdowell XXX Rum contains 180 ml/bottle @ Rs/- 90 each, (ii) 35 bottles Officer Choice whiskey contains 180 ml/bottle @ Rs/- 100 each, (iii) 35 bottles Imperial Blue whiskey contains 180 ml/bottle @ Rs/-120 each, (iv) 05 bottles Imperial Blue whiskey contains 375 ml/bottle @ Rs/-235 each, Total Value Rs.=10,225/-contains with 02(two) nylon bags under proper seizure list from the possession of alleged Gandhi Jana duly signed by the witnesses. I arrest him under proper arrest Memo and brought him into Ps. with seizure articles. During interrogation, he confesses that he is selling liquors illegally from there since long time.

Under the above fact and circumstances, I therefore pray that a case may kindly be started U/S- 46(A) B.E. Act against alleged Gandhi Jana S/o- Lt.-Baranasi Jana of Chalti, P.O.- Basantia, P.S.- Contai, Dist.- Purba Medinipur.
