In producing herewith 01 (one) arrested male accused person namely Santanu Nayak, S/o Tushar Nayak of Uttar Charaikheya, P.S. Contai Dist. Purba Medinipur in custody under proper Memo of Arrest with seized 05 bottles sealed country spirit (Sun)(each 600 ml) duly signed by witnesses and accused person. I PSI Pranab Roy of Contai PS do hereby lodge a complaint, to the effect that today (13.12.16) at 18:55 hrs myself along with force C/877 Chandan Mukherjee & C/542 Nupur Kumar Maity, holding special mobile duty at Satmile Pul Bazar under Contai PS area. As per secret source information reached at Satmile Pul Bazar and held raid I found that Santanu Nayak, S/o Tushar Nayak of Uttar Charaikheya, P.S. Contai Dist. Purba Medinipur is selling Country Spirit illegally in his shop. On being asked he failed to produce any valid documents / license of the above mentioned possessed country spirit. So the seller is arrested.

Accordingly I have seized 05 bottles sealed country spirit after preparing seizure list duly signed by witnesses and accd person. I also prepared label and sample of seized articles.

So I pray that a case has been started against the arrested accused person Santanu Nayak, S/o Tushar Nayak of Uttar Charaikheya, P.S. Contai Dist. Purba Medinipur U/S 46 (A) B.E. Act and arrange for its investigation.
