Sir,

In producing herewith arrested accused namely Surendranath Mondal(43) s/o- Lt. Satish Ch. Mondal of Madhabpur, PS-Durgachak, Dist- Purba Medinipur along with following seized articles as per seizure list I, ASI Dilip Mondal of Durgachak P.S. Dist. Purba Medinipur do here by lodged complaint against Surendranath Mondal(43) s/o- Lt. Satish Ch. Mondal of Madhabpur, PS-Durgachak, Dist- Purba Medinipur to the effect that on 08.04.17 myself along with C/-765 Sanat Das, Civic Sukhendu Mondal & Sanjib Dandapath left PS to perform evening mobile duty at PS area vide Durgachak PS GDE No.297/17 dt- 08.04.17 and C.C.No.796/17 dt.08.04.17, in course of my evening mobile duty on 08.04.17 at about 20:25hrs. received source information that one person was selling Country spirit and ID liquor (Cholai) illegally at Joynagar Bazar to the local public and younger's for gain in exchange of money. The such information informed to Durgachak PS and duty office SI Manik Lal Adak the information was diarized vide Durgachak PS GDE No.305 dt.08.04.17. after that on behalf of O/C Durgachak PS S.I. Sankar Kr. Das directed to me to work out the such information. After that as per order of S.I. S.K. Das we proceed to illegal liquor shop of Surendranath Mondal to work out the information as per order of S.I. S.K.Das on behalf of O/C, Durgachak PS. On seeing the police team some persons flee away from spot. Accordingly conducted raid to the illegal shop at Joynagar Bazar and managed to intercepted the above noted person and interrogated him to spot in respect of selling Country spirit and ID liquor (Cholai) illegally at Joynagar Bazar to the local public and younger's but he failed to produce any valid documents and license of the shop also failed to give any satisfactory answer to me. During interrogated he gave his above noted identity and stated that he is seller of illegal ID liquor and Country spirit there for earning money for maintenance his family because no any other way for maintenance his family. Accordingly recorded his statement u/s 161 Cr.P.C, and arrested him, prepared memo of arrest and seized the following articles as alamat from the illegal liquor shop also prepared seizure list duly signed by the arrested person and available witnesses at spot also labeled.

The list of seized articles as per seizure list which has been seized as alamat.

- i) 08 Glass sealed bottles Country spirit (Captain) 600 M.L. each bottle value of Rs. 65/- each bottle.
- ii) 05 Plastic sealed bottles Country spirit (Sun fighter spirit) 600 M.L. each bottle value of Rs. 65/- each bottle.
- iii) Approx 09 Litters I.D. liquor (Cholai) in plastic Jarican approx value of Rs. 50/-per litter, total value of above seized articles Rs. 1295/-

Taken one bottle from serial No -1 (One) & Taken one bottle from serial No -2(Two) & Taken one litter from serial No -3(Three) as sample.

Under the above facts and circumstances I pray you to start a specific case against the arrested person namely Surendranath Mondal(43) s/o- Lt. Satish Ch. Mondal of Madhabpur, PS-Durgachak, Dist- Purba Medinipur as per law and arrange for its investigation.
