Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Gurupada Patra, S/O - Lt Harekrishna Patra, a permanent resident of Vill-& P.O -Erenda, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 04.04.2017 at about 12:00 PM (noon) I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, both are of (S&LP), Contai Division Office along with Sri Soumen Mondal, AE & SM Egra CCC, Sri Sudip Sasmal, SAE (E), Egra CCC, Sri Bappa Mondal TSH, Egra CCC, and others had been to the village- Erenda under PS Egar for routine inspection purpose. During inspection it was found that Sri Gurupada Patra was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking through single core 7/20 SWG blue coloured PVC coated aluminium conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.64 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 01 (one) number single core 7/20 SWG blue coloured PVC coated aluminium conductor of length 03 (three) meter (approx) along with hooking device as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Gurupada Patra acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 12:30 PM.

Thus the accused Sri Gurupada Patra, S/O - Lt Harekrishna Patra, Vill & P.O - Erenda, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR. The F.I.R is typed by me.
