Sir,

In producing herewith arrested accused person namely Gobinda Rana (51) S/O- Lt. Kalicharan Rana of Madhabpur, PO-Balighai, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Bibek Banerjee of Egra PS do hereby lodge a written complaint after returning at P.S to the effect that today (12.04.17) at 17:05 hrs myself along with C/1244 Ashok Kr. Jana, C/842 Abdul Khalek Khan, and NVF Sk. Rabiul Hossain all of Egra P.S vide C.C. No-590/17 dt-12.04.17 as per secret source information reached at Madhabpur village under Egra PS and held raid in the house of Gobinda Rana (51) S/O- Lt. Kalicharan Rana of Madhabpur, PO-Balighai, P.S Egra, Dist-Purba Medinipur and found that he was selling Foreign liquor and ID liquor illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed liquor. On being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized (i) 10 (Ten) sealed bottles of McDowell's No.1 Rum per bottle 180 ml x 10 = 1800 ml and each bottle cost of Rs-90 x 10 = 900/- (Rupees nine hundred) only (ii) 10 (Ten) Liters ID liquor with Jarican, per liter cost of Rs 100/- X 10 = 1000/- (Rupees One thousand) and one nylon bag. Total cost of Rs. 1900/- (Rupees One thousand nine hundred) only as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry it has been learnt that the above noted accused person selling Foreign liquor and ID liquor illegally since long.

So, I do hereby lodge a written complaint against above mentioned Gobinda Rana (51) S/O- Lt. Kalicharan Rana of Madhabpur, PO-Balighai, P.S Egra, Dist-Purba Medinipur for violation U/S-46A (C) of Bengal Excise Act-1909 with a request for starting a case.
