Sir,

In producing herewith arrested accused person namely Paban Jana(50) S/O-Lt. Ananta Jana of Dubda, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Deb Prasad Samanta of Egra PS do hereby lodge a written complaint after returning at P.S to the effect that today (23.09.17) at 06:05 hrs myself along with C/1648 Haripada Mohanti, NVF Kalachand Jana of Egra P.S vide C.C. No-2208/17 dt-22.09.17 as per secret source information reached at Dubda village under Egra PS and held raid in the house of Paban Jana(50) S/O-Lt. Ananta Jana of Dubda, P.S Egra, Dist-Purba Medinipur and found that he was selling Country Spirit illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed liquor. On being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized 10 (Ten) sealed bottles of Sun country Spirit each bottle contains 600 ml x 10=6000 ml and each bottle cost of Rs-65 x 10= Rs 650/- (Rupees Six Hundred Fifty) only with one nylon bag as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person selling Country Spirit illegally since long.

So, I do hereby lodge a written complaint against above mentioned Paban Jana(50) S/O-Lt. Ananta Jana of Dubda, P.S Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act-1909 with a request for starting a case.
