In producing herewith 01 (One) arrested male accused person Paran Hembram (60) S/O Dandu Hembram of Chorpalia, P.S. Egra, Dist-Purba Medinipur in custody under proper Memo of Arrest and seized the following items as per seizure list duly signed by the witnesses and accused person. I beg to state that I ASI Dilip Kumar Jana of Egra PS do hereby lodged a complaint after returning at PS, to the effect that today (13/02/17) at 18.35 hrs myself to accompany force of C/1193 Dilip Kr Bar - C/ 151-Sk Nazrul Hossion C/577 Pintu Issue all of Egra P.S vide Egra P.S C.C.No.370/17 dated 13/02/17 during mobile duty at Vill- Chorpalia & received secret source information that the above noted arrested person selling illegally I.D liquor at his house at Chorpalia. On the basis of source information held raid and arrested the above noted person who is selling illegally I.D liquor. On being asked the above noted arrested accused could not produce any valid documents of selling permission and she admitted that he is running this business since long. Accordingly I seized (i) 05 (five) Liter I.D Liquir in a plastic jarican, Rs 100/- (one hundred) per liter .05 Ltr.x1000ML =5000 ML and Rs.100x05 =500(five hundred) only and arrested his u/s-46C of B.E.Act-1909 as she liable for this offense informed his ground of arrest by issuing Memo of arrest. I also prepared label and sample of seized articles.

So I do hereby lodge a written complaint against above mentioned Paran Hembram (60) S/O Dandu Hembram of Chorpalia, P.S.-Egra, Dist-Purba Medinipur for violation of Act u/s-46 C of Bengal Excise Act-1909 with a request the O/C Egra PS for starting a case.
