On the basis of source information held raid and arrested the above noted person who is selling illegally I.D liquor. On being asked the above noted arrested accused could not produce any valid documents of selling permission and she admitted that he is running this business since long. Accordingly I seized (i) 05 (five) Liter I.D Liquir in a plastic jarican ,Rs 100/- (one hundred) per liter .05 Ltr.x1000ML =5000 MLand Rs.100x05 =500(five hundred) only and arrested his u/s-46C of B.E.Act-1909 as she liable for this offense informed his ground of arrest by issuing Memo of arrest, I also prepared label and sample of seized articles.

So I do hereby lodge a written complaint against above mentioned Paran Hembram (60) S/O Dandu Hembram of Chorpalia ,PS-Egra, Dist-Purba Medinipur for violation of Act u/s-46 C of Bengal Excise Act.-1909 with a request the O/C Egra PS for starting a case.
