Dear Sir.

1, do Sureby lodged this written complaint empowered by the Electricity Act'2003 read with Amendment Act'2007 against Sri Prasanta Gurey S/O - Lt. Subol Gurey of Madhavpur, PS- Kolaghat, Dist- Purba Medinipur for commission of theft in respect of Electricity U/S 135 of Electricity Act'2003 read with Amendment Act'2007 which stated here under in brief.

Today i.e. 20.12.2016 at 12:15 hours I, Sri Pranabesh Majee, A.E.& S.M, Gopalnagar CCC along with (i) Sri Jugal Kishore Poria, H.G.Sr.L.M, Gopalnagar CCC & other officials had been to the village Madhavpur for inspection & checking purpose of energy meter. During inspection we went to the domestic premises of Sri Prasanta Gurey S/O - Lt. Subol Gurey of Madhavpur, PS- Kolaghat, Dist- Purba Medinipur and it was found that. Sri Prasanta Gurey S/O - Lt. Subol Gurey was consuming electricity unauthorisedly by way of direct hooking from the nearest L.T.O.H. mains of W.B.S.E.D.C.L. in the tune of load 0.300KVA causing, loss of revenue of W.B.S.E.D.C.L.

As the theft of Electricity was detected, at first I disconnected the hooking device from W.B.S.E.D.C.L. mains and thereafter I seized some portion of hooking device, like PVC wire, single core, Black in colour approx. 30.0 metre, under a memo of the seizure list in presence of witnesses & representative of the consumer Smt. Pratima Gurey & their signature was duly obtained on the seizure list. Then I labled & packed the seizure articles at the inspection site & the signature of the witnesses also obtained on the packed & lable. The witnesses & representative of the consumer signed on the inspection report also. The inspection team left the premises at 12:50 hours.

Under the above circumstances, you are requested to start a case against Sri Prasanta Gurey S/O - Lt. Subol Gurey of Madhavpur, PS- Kolaghat, Dist- Purba Medinipur U/S 135 (i) (a) of Electricity Act'2003 read with Amendment Act'2007 for commission of theft in respect of electricity dishonestly.

Over this, you are requested to take cognizance of the above subject & treated the same as F.I.R.
