Myself SI Molay Adhikary of Henria I/C under Khejuri PS in producing here with the arrested Biseswar Jana (32) S/O Kripasindhu of Amdabad, PS Nandigram, Dist Pürba Medinipur along with seized articles, I beg to report that I along with force Cons/- 850 Chinmoy Tamli, CVF/-315 Arindam Jana, CVF/- 236 Somsundar Bar of Henria I/C pursuance of a secret source information on 22,03.17 at 20.15 hrs that one above noted person is running a business of selling ID liquor, country liquors without any license at Udhakhali bus stand near Jatri Pratikhaloy. So the peruse the information myself along with force rushed to said place and found that one above noted person is selling different type of liquor to the different customers. On seeing the police team all tried to run away but police managed to apprehend the seller, who was selling liquors at the said place. On interrogation he disclosed his name and address as above.
