Respected Sir,

Myself ASI Dibyendu Biswas of Henria I/C under Khejuri PS in producing here with the arrested Ranjan Mondal (30) S/O Lt Arun Mondal of Sarbeswar Chak, PS Khejuri, Dist Purba Medinipur along with seized articles, I beg to report that pursuance of a secret source information on 22.03.17 at 20.45 hrs that one above noted person is running a business of selling ID liquor, country liquors without any license at Henria Abha Maity bus stand. So the peruse the information myself along with force rushed to said place and found that one above noted person is selling different type of liquor to the different customers. On seeing the police team all tried to run away but police managed to apprehend the seller, who was selling liquors at the said place. On interrogation he disclosed his name and address as above. On searched the below noted liquors were found. On enquiry it was known that he was conducting the business of selling of liquor without any license since last few months. On demand he failed to produce any license for stock and selling of the liquors and any papers regarding possession of such quantity of liquors. So the below noted quantity of liquors were seized from his possession under proper seizure list in between 20.55 to 21.10 hrs and he was arrested.

Description of the seized items (1) Country Sprit 07 Pieces (600 ml.) X Rs 65 =Rs. 455/-, Total Rs. 455/-

I also took one bottle from the above mentioned categories as sample.

So a case U/S 46A(c) of Bengal Excise Act 1909 may kindly be started against accused Ranjan Mondal (30) S/O Lt Arun Mondal of Bansgora, PS Khejuri, Dist Purba Medinipur.
