Respected Sir,

Myself ASI Saibal Maity of Henria I/C under Khejuri PS in producing here with the arrested Bikash Adak (45) S/O Lt Jagadish Adak of village Alaichak, PS Khejuri, Dist Purba Medinipur along with seized articles, I beg to report that pursuance of a secret source information on 04.04.17 at 08.15 hrs that one above noted person is running a business of selling I.D liquor, without any license at Dakshin Kalamdan bus stand near Petrol pump. So the peruse the information myself along with force rushed to said place and found that one above noted person is selling different type of liquor to the different customers. On seeing the police team all tried to run away but police managed to apprehend the seller, who was selling liquors at the said place. On interrogation he disclosed his name and address as above. On searched the below noted liquors were found. On enquiry it was known that he was conducting the business of selling of liquor without any license since last few months. On demand he failed to produce any license for stock and selling of the liquors and any papers regarding possession of such quantity of liquors. So the below noted quantity of liquors were seized from his possession under proper seizure list in between 08.55 to 09.10 hrs and he was arrested.

Description of the seized items (1) I.D liquor 03 lts X Rs. 50/- = Rs/- 150/- Total Rs. 150/-

I also took one bottle from the above mentioned categories as sample.

So a case U/S 46A(c) of Bengal Excise Act 1909 may kindly be started against accused Bikash Adak (45) S/O Lt Jagadish Adak of village Alaichak, PS Khejuri, Dist Purba Medinipur.
