Sir, I do hereby lodge a complaint empowered by the Electricity Act, 2003 to the effect that Saddam Malik, S/O - Kulubud of Vill. Gopalchak P.S. Mahishadal, Dist. Purba Medinipur has committed theft of electricity u/s-135 of the Electricity Act, 2003 read with Amendment Act 2007 as stated here under on 19.12.2016 at 2.30 P.M. I, Sd. Bibhas Roy, D.F. 2 Station Manager, Mahishadal customer care centre, along with 1) Subratik Bhattacharyee, SAE (E) and Amar Gopal Indranik SAE (E) of Mahishadal customer care centre visited the premises of Saddam Malik, and found that Saddam Malik was consuming electricity by direct hooking from LT to HT, causing loss of WBSF DCL's revenue. As theft of electricity was detected during inspection a portion of hooking wire have been seized in the presence of witnesses and their signature obtained on the seized list. The inspection team left the aforesaid area at 3.00 P.M.

The accused Saddam Malik, has committed an offence u/s 135(1)(a) of the Electricity Act, 2003 read with Amendment Act 2007. Hence you are requested to take cognizance of this complaint and treat it as F.I.R.
