I do hereby lodge a complaint, empowered by the Electricity Act, 2003 to file effect that Saddam Mallik, Sl.no- Kultubed of Vill. Gopalchak P.S. Mahishadal, Dist. Purba Medinipur has committed theft of electricity u/s. 135 of the Electricity Act, 2003 read with Amendment Act 2007 as stated here under on 19.12.2016 at 2.30 P.M. I Sri Bibhas Roy, D.F & Station Manager, Mahishadal customer care center, along with 1) Subraksh Battacharjee, SAE (E) and 2) Mr. Gopal Pratapnik SAE (E) of Mahishadal customer care centre visited the premises of Saddam Mallik, and found that Saddam Mallik was consuming electricity by direct hooking from L.T.C.I., causing loss of WBSE DCL's revenue. A theft of electricity was detected during inspection, a portion of hooking wire have been seized in the presence of witnesses and their signature obtained on the seized list. The inspection team left the aforesaid area, at 3.00 P.M.

The accused Saddam Mallik, has committed an offence u/s. 135(1)(a) of the Electricity Act, 2003 read with Amendment Act 2007. Hence you are requested to take cognizance of this complaint and treat it as P.I.R.
