Sir, I do hereby lodge a complaint empowered by the Electricity Act, 2003 to the effect that Somser Sekh, S/O. Lt. St. Yusuf of Vill. Dakshin Belkurdia, P.O. Mahishadal, Dist. Purba Medinipur, has committed theft of electricity u/s. 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under on 19.12.2016 at 3.30 P.M. I, Sri Bikhas Roy, P.E 2, Station Manager, Mahishadal Customer Care Centre, along with 1) Subratik Bhattacharjee, SPE (E) and Amar Gopal Pramanik, SPE (E) of Mahishadal Customer Care Centre visited the premises of Somser Sekh and found that Somser Sekh was consuming electricity by direct hooking from LTOM, causing loss of WBSFDEL's revenue. As theft of electricity was detected during inspection a portion of hooking wire have been seized in the presence of witnesses and their signature obtained on the seized list. The inspection team left the aforesaid area, at 3.45 P.M.

The accused, Somser Sekh, has committed an offence u/s. 135(1)(a) of the Electricity Act 2003 read with Amendment Act 2007. Hence you are requested to take cognizance of this complaint and treat it as F.I.R.
