Sir, I do hereby lodge a complaint empowered by the Electricity Act 2003 to the effect that Sh. Habibulla, Sl. No. A 3444 of vill 4 of 2003, Mahishadal Dist. Purba Medinipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under on 10-02-2016 at 3:15 Pm. I Sri Bibhas Roy, D.T.O & Station Manager Mahishadal Customer Care Centre along with D. Subrata Bhattacharjee STF(E) and Amar Gopal Pramanik STF(E) of Mahishadal Customer care centre visited the premises of Sh. Habibulla and found that Sh. Habibulla was consuming electricity by direct hooking from L TOH, causing loss of WBSEB DCL's revenue. As theft of electricity was detected during inspection of portion of hooking wire have been seized in the presence of witness and their signature obtained on the seized list. The inspection team left the aforesaid area at 3:30 Pm.
