Sir, I do hereby lodge a complaint empowered by the Electricity Act 2003 to the effect that Sh. Habibulla, S/o. H. Sanyal of village Akshin Beldunda, P.S. Mahishadal, Dist. Purba Medinipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under on 10.12.2016 at 3.15 P.M. I, Sri Bibhas Roy, D.F. & Station Manager Mahishadal Customer Care Centre along with 1) Supnolik Bhattacharjee SFF (E) and Amar Gopal Pramanik SFF (E) of Mahishadal Customer Care Centre visited the premises of Sh. Habibulla and found that Sh. Habibulla was consuming electricity by direct hooking from L.T.O.H. causing loss of WBSE DCL's revenue. As theft of electricity was detected during inspection a portion of hooking wire have been seized in the presence of witnesses and their signature obtained on the seized list. The inspection team left the aforesaid area at 3.30 P.M.

The accused Sh. Habibulla has committed an offence u/s-135(1)(a) of the Electricity Act 2003 read with Amendment Act 2007. Hence you are requested to take cognizance of this complaint and treat it as F.I.R.
