In producing herewith one arrested accused person namely Suman Mandal (32), s/o -Jhantu Mandal of Vill. - Gangra, PS - Nandigram, Dist - Purba Medinipur under arrest along with following seized articles as per seizure list and relevant documents. I SI Debabrata Bera attached with Nandigram PS, Dist. - Purba Medinipur do hereby lodged a written complaint against the above noted accused person as suomoto to the effect that today (06.04.2017) at about 19:15 hrs in course of my evening mobile duty received information that one person is selling LD liquors at Sonachura Bazar. Then I informed O/C Nandigram PS and as per his order I along with forces of Nandigram PS left for Sonachura Bazar to work out the information. We reached at Sonachura Bazar at about 20:05 hrs and found the above noted accused person is selling I.D liquor illegally in open place at Sonachura Bazar. Then we came close to the spot and all the customers successfully fled away and we chased him and able to intercept the above noted accused person. The arrested accused person failed to produce any valid license/documents in favor of such business and possession of LD liquor. On interrogation he confessed his guilt. As the said accused person such possession of I/D liquor having no license. He is running such type of clandestine business without obeying the provision of the Bengal Excise Act. He is committed an offence U/S 46 A(c) of B.E. Act of 1909. So I arrested him and seized (1) one 10 liters far cane containing 08 liters (approx) LD liquors (value - Rs. 800/approx) from his possession after preparing seizure list with label duly signed by the witnesses and the accused person with (2) one 375 ML glass bottle containing such LD liquor collected from that [ar cane as sample with label.

I therefore pray that a suitable case may be initiated against the above noted accused person under proper section of law.
