I do hereby lodged a complaint empowered by the electricity Act 2003 read with amendment act 2007 to the effect that Samir Ranjan Adhikary S/o-Gunadhar Adnikary,Vill.-Reyapara,P.S-Nandigram Dist- Purba Mednipur has committed theft of electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated here under.

On 14.12.2016 at about 01.55 pm I,Sri Shyamsundar Mondal AE(E) & SM,Nandigram CCC along with Manik Pal (SAE), Uttam Kr Maity (LM),Manik Lal Maity (Sr. TSH) all of Nandigram CCC with other official entered to the domestic premises of Samir Ranjan Adhikary S/o-Gunadhar Adhikary,Vill.-Reyapara,P.S.-Nandigram Dist- Purba Mednipur and during inspection it was found that Samir Ranjan Adhikary S/o-Gunadhar Adhikary has got one energy meter bearing meter no-LL156923 & Con ID-222077772, But instead of that he was consuming electricity dishonestly by way of bypassing arrangement to the incoming side of the service cable before entry to the energy meter for less recording of energy unit in meter to run his domestic premises causing loss of revenue to WBSEDCL to the tune of load 0.54 KVA.

As the Theft was detected during the inspection, the service connection was disconnected and removed the service cable from L.T Mains and thereafter some portion of PVC cable black color two core 2 mtr. Approximate and one yellow card sl.no.521293 in the name of Samir Ranjan Adhikary was seized under a memo of seizure list in presence of witnesses and obtained their signature on the seizure list accordingly. Above seizure articles duly packed, labeled and then the signature of the witnesses also obtained on it. I also prepared an inspection report at site with duly signed by witnesses. After completion the inspection, the inspection team left the premises at 02.15 pm.

Thus the accused Samir Ranjan Adhikary S/o-Gunadhar Adhikary,Vill.-Reyapara,P.S.-Nandigram Dist- Purba Mednipur has committed an offence under section 135(i)(b) of the electricity act 2003 read with amendment act 2007 in view of theft of electricity through direct hooking for less recording of energy for his wrongful gain.
