The Officer in charge, Nandigram P.S., Purba Medinipur,

Sir.

In producing herewith one accused person namely Swapan Kumar Manna (54) S/o LT Sukesh Ch. Manna of Vill - Osmanchak PS Nandigram Dist - Purba Medinipur under arrest along with following seized articles as per seizure list and relevant documents. I ASI Aniruddha Chakraborty attached with Nandigram PS Dist. Purba Medinipur do hereby lodged a complaint against the above noted accused persons as suomoto to the effect that today (16.12.16) at 18.45 hrs in course of my mobile duty received information that one person is selling I.D liquors at village Osmanchak . Then I informed O/C Nandigram and I along with C/1559 Uttam Ghosh, C/1615 Rasbhari Barik both attached at Nandigram PS left for Osmanchak to work out the information. We reached at Osmanchak at about 19.15 hrs and found the above noted accused person was selling I.D liquor in his house. Then we came close to the spot and all the customers successfully fled away and we chased and able to intercept the above noted accused person and detained him. The accused person failed to produce any valid license/documents in favor of such business and possession of I.D liquor. On interrogation the above noted accused person confessed his guilt. As the said accused person such possession of I/.D liquor having no license and he is running such type of clandestine business without obeying the provision of the Bengal Excise Act. He is committed an offence U/S 46(A)(c) B.E. Act-of 1909. So, I arrested him and seized (1) one Jar cane 20 liters containing 17 Ltrs (approx) I.D liquors (value - Rs. 1700/- approx) from his possession. After preparing seizure list with label duly signed by the witnesses and the accused person with (2) one 375 ML glass bottle containing such I.D liquor collected from that Jar cane as sample with label.

I therefore, pray that a suitable case may be initiated against the above noted accused persons under proper section of law.
