Dear Sir,

I do hereby lodge a written complaint, against one Sri Rabi Maji S/O- Lt. Bhim maji of Vill.-Kulia, P.O.-Amdan, P.S -Panskura, Dist- Purba Medinipur for commission of theft in respect of electricity as stated hereunder.

On 5.04.2017 at 2.40 p.m, I, Sri Soumen Mondal D.E & S.M. Pratappur C.C.C along with (1) Sk. Kohinoor Ali, Sr. S.A.E(E) (2) Sri Niladri Chakraborty, Sr. S.A.E(E) from Pratappur CCC and other technical staff had been to the village Kulia for raid & inspection purpose. During inspection it was found that Sri Rabi Maji S/O- Lt. Bhim maji of Vill.-Kulia, P.O.-Amdan, P.S -Panskura, Dist- Purba Medinipur was operating a motor for agriculture purpose dishonestly by way of direct hooking from nearby LT mains for his wrongful gain causing loss of revenue of WBSEDCL. Sri Rabi Maji has committed theft in respect of the tune of load 0.5Kw which ascertained from the physical inspection.

As theft of electricity was detected during inspection, the unauthorized hooking wire was removed from LT main and thereafter some portion of hooking wire single core 2wire pvc cable red & black in colour (approx. length of 1.5 mtr approx) with hooking device were seized in presence of the witnesses under a memo of seizure list and their signature duly contained on it.

The above materials were duly packed and labeled at the inspection site and signature of the witnesses obtained on the Packed & label. I also prepared an inspection report at site & duly signed by the witnesses on it. After inspection our inspection team left the premises at 3.10 p.m.

Thus the accused person i.e Sri Rabi Maji S/O- Lt. Bhim maji of Vill.-Kulia, P.O.-Amdan, P.S -Panskura, Dist- Purba Medinipur has committed an offence u/s 135(1) of the Electricity Act 2003 read with amendment Act 2007 in view of theft of electricity.

So you are requested to take cognizance of this complaint and treat it as FIR.
