I do hereby lodge this written complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that one Sri Biswaranjan Jana , S/O: Sri Binay Krishna Jana of Village + P.O : Gokulpur, P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135 of the electricity act 2003 with amendment act 2007 as stated hereunder.

On 07.04.2017 at about 1.30 pm [,Sri Aniruddha Hazra, AE & SM, Patashpur CCC along with Sri Arunangshu Mondal , SAE (E), Patashpur CCC & Sri Trilochan Bagdi, Hg. Sr. TSH, Patashpur CCC and others went to inspect the agricultural field of Gokulpur mouza as a part of routine supervisory checking and found that one Sri Biswaranjan Jana, S/O:Sri Binay Krishna Jana of the same village was engaged in unauthorized use of electricity at his agricultural premises by means of bypassing of the installed energy meter GX009528 through forming one loop connection by connecting 3 no separate blue colour PVC coated 7/16 SWG aluminum conductor from the LT bushing side of nearby distribution transformer to the installed cut out after the installed energy meter GX009528 at the said premises with consumer id 200903631. The said illegal loop connection was such formed to run one electrical STW motor of a tune of load of 4.52 KVA i.e, around 5 HP in such a way that less energy will be recorded at the said energy meter for his wrongful gain causing considerable loss of revenue and energy of WBSEDCL.

As theft of electricity was detected, at first said electrical service connection with consumer id-200903631 was disconnected from the live electrical network of WBSEDCL and then the said three no blue colour PVC coated 7/16 SWG aluminum conductor which was used to form the said unauthorized loop connection for meter bypassing was disconnected from the electrical live network and some portion approx. i.e, around 2 meter each of the said 3 no blue colour PVC coated conductor as sample along with the hooking device was seized in presence of the witness and signature of the witness obtained on the seizure list. The seized article were duly packed and labeled at the inspection site and the signature of the witness obtained on the label. Sri Biswaranjan Jana was present during inspection but refused to sign. The inspection team left the aforesaid premises at about 2.10 pm.

The accused Sri Biswaranjan Jana , S/O:Sri Bino; Krishna Jana of Village + P.O : Gokulpur, P.S.: Patashpur, Dist.: Purba Medinipur has committed theft of electricity under section 135(i)(b) of electricity act 2003 with amendment act 2007.

You are hereby requested to take cognizance of this offence and treat this complaint as FIR. The FIR is typed by the undersigned.
