Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Sk. Jomal Uddin (34) S/O- Sk. Osman Ali of Chak Sriradhe PS Tumluk, Dist Purba Medinipur along with the below noted seized items, I ASI Sudhangshu Samanta of Panskura PS beg to state that on my Special Raid duty at PS area on 08/12/16 at about 14.25 hrs. received a secret source information that, one person named as Sk. Jomal Uddin is running a business of selling of I/D liquors to different person at Road Side of Rajnarayanchak under Panskura PS. To pursue the information myself along with C/ 1696 Ekadosi Dhal and C/645 Debeprasad Dawn left for village Rajnarayanchak after having inform to OC, Panskura PS. I reached at Rajnarayanchak at 17.05 hrs and as pointed by my source we cordoned the road side area of Sk. Jamal Uddin where he was selling I.D liquor, seeing the police force the persons purchasing the I/D liquors managed to run away but we managed to apprehend the above named Sk. Jomal Uddin, who was selling 1/D liquors. We approached local people to witness the search and seizure but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched him and below noted quantity of I/D liquor was found from the bag on his possession. On enquiry it was known he was businesses of selling of I/D liquor since last few days. On demand he failed to produce any license for possession of the I/D liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 17.05 hrs to 17.30 hrs on 08/12/16. Description of the seized items:-1) I/D liquor contained in one 5 ltrs. Plastic jarican containing approximately 05 lts. 2). I also took 375 ml of ID liquor in a bottle as sample, from the above mentioned seized item. I arrest him at 07.30 hrs on 08/12/16 and brought him to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against him U/S 46 A(c) of B.E Act . On arrest, all arrest formalities maintained and inform his family members regarding arrest.
