In producing herewith one arrested male accused person namely Ganesh Shit (42) 500 Shit of vill Gobardhanpur, P.S-Patashpur, Dist Purba Medinipur, in custody under some memo of arrest with seized articles all relevant papers. I beg to submit report that on 10.12.16 at 20:15 hrs during Evening mobile duty I ASI Shyamal Deb of Patashpur acceived information by reliable source that one person Ganesh Shit s/o Lt Bhanu Shit of Il Gobardhanpur, P.S-Patashpur, Dist Purba Medinipur, selling Country spirit Gooddhanpur area under Patashpur PS to local people in lieu of money without any nuthorization. After receiving the said information I informed to O/C Patashpur PS and as per order by O/C Patashpur PS, myself along with force rushed to the spot at 20:30 hrs at Gobardhanpur for holding raid and work out over such information at the Gobardhanpur, and found one person selling Country spirit by the road side to local people. After a chase I managed to apprehend a person as shown by my source. On being asked the apprehended person disclosed his identity as Ganesh Shit s/o Lt Bhanu Shit of vill Gobardhanpur, P.S-Patashpur, Dist .Purba Medinipur . Then I conducted search to him after observing all in presence of the witnesses . On search I found 04 (four) bottles of SUN Country Spirit (Containing 600 ml each, Rs 55/- @ bottles, Total Rs 220/-) in a bag from his possession at Gobardhanpur. On interrogation said Ganesh Shit disclosed to me that he selling such Country Spirit to local people illegally. He was asked whether he had any valid papers in support in respect of such businesses and possession of such Country spirit but he unable to produce any valid document on demand or to have any paper for the such of Country Spirit. Hence his offence is punishable U/S 46 A(c)of the Bengal Excise Act.

Accordingly the Country Spirit were seized from the possession of the accused Ganesh Shit s/o Lt Bhanu Shit of vill Gobardhanpur, P.S-Patashpur, Dist Purba Medinipu under proper seizure list duly signed by witnesses and the accused person and I arrested him as his offence is punishable u/s 46 A (c) of Bengal Excise Act 1909 During arrest the accused persons was informed about the ground of his arrest and memo of arrest was prepared

and provided all sorts of assistance as per law.

Under such circumstances I do hereby lodged complaint against accused Ganesh Shit (42) s/o Lt Bhanu Shit of vill Gobardhanpur, P.S-Patashpur, Dist Purba Medinipu who violated U/S 46 A (c) of the Bengal Excise Act,1909 to initiate a case for investigation.
