Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Sunil Maikap, S/O - Lt Bijoy Krishna Maikap, a permanent resident of Vill & P.O -Soulabheri, P.S -Patashpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 15.12.2016 at about 02:00 PM I, Sri Manas Maity, A.E.(U), (S&LP), Sri Pradip Kr. Chakraborty, SO, (S&LP), Contai Division Office along with Sri Aniruddha Hazra, AE & SM A.E & S.M, Patashpur CCC, Sri Bechan Prasad Barai, Hg. Sr. LM and others had been to the village- Soulabheri for routine inspection purpose. During inspection it was found that Sri Sunil Maikap was consuming electricity dishonestly in his agriculture premises through 2 (two) nos. separated yellow colour PVC coated stranded aluminum conductor along with hooking device unauthorisedly by way of direct hooking from the nearby LT source of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 1.75 KVA.

As theft of electricity was detected during inspection the illegal hooking was dismantled & removed from our LT source and some portion of 2 (two) nos separated yellow colour PVC coated stranded aluminium conductor of length two meter each (approx) along with hooking device and one switch board (4 inch x 6 inch) with 2 nos 5 amp switch, 2 nos 5 amp, 5 pin plug socket and one indicator used to run the electrical pump-motor set unauthorisely for agricultural purpose were seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Sunil Maikap acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:30 PM.

Thus the accused Sri Sunil Maikap, S/O - Lt Bijoy Krishna Maikap, Vill & P.O - Soulabheri, , P.S -Patashpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) [a] of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
