Sir,

In producing herewith the arrested accused person namely Rajesh Sasmal (65) s/o Lt. Jhareswar Sasmal of Vill-Talgachari, PS. Ramnagar, Dist. Purba Medinipur, along with 05 (five) bottles Country Spirit each 600ml I, SI Madhab Das of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 20.03.17 at 18.05 hrs I, along with C/840 Tapan Shit and C/1535 Bikash Tamang both of Ramnagar PS left for mobile duty vide Ramnagar PS GDE No. 1156 dt. 20.03.17. During mobile duty on 20.03.17 at 18.45 hrs we found that the above noted accused person is selling liquors to the different customers at Talgachari under Ramnagar PS from his temporary shop. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing/ selling of the liquors and any paper regarding possession of such quantity of liquors. So, I seized below noted quantity of liquors from his possession under proper seizure list and label duly signed by the witnesses on 20.03.17 in between 18:55 hrs to 19:10 hrs and also arrested the above noted accused person on 20.03.17 at 18.50 hrs.

Description of the seized items:

1) Country Spirit each 600 ml. X 05 (five) bottles.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Rajesh Sasmal (65) s/o Lt. Jhareswar Sasmal of Vill-Talgachari, PS. Ramnagar, Dist. Purba Medinipur, U/S 46A(c) of Bengal Excise Act-1909.
