Sir,

I do hereby lodge complain empowered by the Electricity Act – 2003 to the effect that Sri Purushottam Nayak, S/o- Bimal Nayak, Vill. & P.O. - Islampur, P.S. - Ramnagar has committed theft of electricity U/S - 135(i) (b) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 23/03/2017 at about 12.10 p.m. I, Sri Jayanta Panda, AE & SM, Pichhaboni C.C.C along with Sri Ramkrishna Jana, LM, Sri Rajkishor Das, TSH and others all attached with Pichhaboni C.C.C inspected the premises of Sri Purushottam Nayak residing at Islampur after maintaining all formalities. During inspection it was found that Sri Purushottam Nayak is using electricity by means of bypassing the energy meter by tempering the incoming service cable before entry into the energy meter in respect of Consumer Id No: 201596351, Meter No: TA558658, in view of less recording of unit or energy in to the energy meter, causing loss of revenue of WBSE.D.C.L.

Therefore, as theft of electricity was detected in the manner of U/S- 135(i) (b) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was domestic with detected load of 0.58 KVA. The unauthorized line was disconnected and removed at site.

Some portion of dual core PVC cable black in colour along with tapping arrangement of length 2 feet approx and two separate copper wire red in colour of length 2 feet each approx and meter vide meter no: TA558658 were seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 12.30 p.m. on 23/03/2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
