I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Baneswar Bera S/o Lt. Jiten Bera, Vill- Durgapur, Po-Agadoro, PS- Sutahata, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated bereunder.

On 23.03.2017 about 01.25pm I, Vudatha Vinod Kumar, AE & SM, Chaitanyapur CCC, Purba Medinipur along with Rajkamal Nayak (SAE), Arjun Bera (L.M) and Bholanath Duley (TSH) of Chaitanyapur CCC & Other official went to the domestic premises of Baneswar Bera S/o Lt. Jiten Bera, Vill- Durgapur, Po-Agadero, PS- Sutahata, Dist- Purba Medinipur for inspection purpose.

During inspection it was found that Baneswar Bera S/o Lt. Jiten Bera was consuming electricity dishonestly by the way of direct hooking from nearby LTOH line through P.V.C wire for domestic purpose at a tune of load 0.76 KVA causing loss of revenue to WBSEDCL...

As the theft of electricity was detected, the unauthorized wire was disconnected and removed from the L.T line and there after some portions of hooking wire single core PVC wire 5 mtr. Approx (white& blue colour) along with hooking device and one CFL (15w) was seized in the presence of witnesses under a memo of seizure list and duly signed by them. The above seized articles were packed and labeled and signature of witnesses also obtained on the label. I also prepared an inspection report at spot duly signed by the witnesses. I also approach to accused person for signature in the seizure list & inspection report but they refused to sign and I also approached to produce documentary evidence related to ownership of the house but also refused to produce it. From local enquiry it is learnt that ownership of the house belongs to Baneswar Bera S/o Lt. Jiten Bera. After completion of inspection we left the spot at 01.40 pm.

Thus the accused Baneswar Bera S/o Lt. Jiten Bera, Vill- Durgapur, Po-Agadoro, PS- Sutabata, Dist-Purba Medinipur has committed offence U/S 135/(i)(a) of the Electricity Act 2003 read with Amendment act 2007 in view of theft of electricity.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F I.R.
