Sir.

In producing herewith one Gurupada Khanra (60 yrs) s/o Lt. Rashbehari Khanra of Dihi Shibramnagar, PS Sutahata, Dist. Purba Medinipur along with seized articles i.e. 10 Ltrs ID liquor (Chullu) I, ASI Sambu Mondal of Sutahata P.S. lodge a complaint as suo-moto against above noted charge person to the effect that on 27.01.17 at 14:45hrs myself along with C/202 Sekhar Naskar, C/1230 Bharat Chalak vide CC No. 248 dt. 27.01.17 left P.S. for holding special raid at P.S. area. About 14:35 hrs. received a telephonic information from duty officer ASI B.K. Dhua from reliable source regarding hoarding, selling, I/D liquors at Dihi Shibramnagar illegally by the charge person and gaining profit out of it. After receiving such information duty officer informed to O/C Sutahata P.S. about the matter he suggested me to conduct raid immediately without delay for attending Excise Department also informed to O/C excise Mahisadal circle about the matter. After that as per direction of O/C myself along with force had been to Dihi Shibramnagar and found that one person was selling ID liquor illegally to the local public and younger's from his house cum shop.

On arrival at Dihi Shibramnagar I found that charge person was selling ID liquor with a plastic Jerkin contents 10 Ltrs (approx) of ID liquor (Chullu). Some customers were present there and on seeing the police they fled away from the place. So, I conducted search and intercepted the above noted person and seized following articles in between 15:20hrs to 15:55hrs from his possession on being asked he disclosed his above noted identity and request to produce any documents / license for his such possession of alcoholic but he failed to produced the any valid documents before me in respect of ID liquors which was he selling illegally. The description of seized articles is as follows: 10 liters of I/D liquor (Chullu) containing in a plastic jerry-can Rs. 500/- (approx) of I/D liquor (Chullu) and collected 375ml as sample in a bottle. I prepared memo of arrest and seizure list also label under proper seizure list by obtaining signature of owner and witnesses. In absence of any disinterested persons he had to register the help of Police Party who were accompanying to me. The seller i.e. charge person was dealing in this illicit liquor illegally without valid documents. Hence, his act is punishable under Bengal Excise Act 1909. So I arrested him namely Gurupada Khanra (60 yrs) s/o Lt. Rashbehari Khanra of Dihi Shibramnagar, PS Sutahata, Dist. Purba Medinipur and brought to P.S. under proper escort after observing all extension of medical and legal aid given to him from our end but he declined to take any. Under the above noted circumstances his act is punishable u/s 46(A) Bengal Excise Act 1909.

Accordingly I request to O/C Sutahata P.S. for starting a specific case against the above noted person u/s 46(A) Bengal Excise Act 1909 over this issue SI Amit Deb, O/C Sutahata P.S. recorded above referred case against him and directed to ASI Arun Kr. Divasi to investigate the case.
