In producing herewith arrested accused person namely Barun Maity, age 42 yrs s/o Pashupati Maity of Rajhati, PO- Haridaspur, P.S.- Tamluk, Dist- Purba Medinipur along with the seized articles (i) Twenty (20) bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle under proper seizure list. I ASI Nandalal Mahakul of Tamluk P.S. do hereby lodged complaint to the effect that on 25.03.2017 at 07.45 hrs. myself along with C/1120 Sanjay Bhowmik, NVF Chandra Sekhar Bhowmik left P.S. to perform morning mobile duty vide Tamluk P.S. G.D.E. no. 1321 dated 25.03.2017 and C.C. no 1216 dated 25.03.17. In course of morning mobile duty at 13.05 hrs at Radhamoni received secret information from my reliable source that one person carrying country sprit illegally at Damodarpur bus stand. We reached at Damodarpur Bus Stand and found one person standing there with a jute bag containing something in the bag. As identified by my secret source and apprehended the country spirit carrier in presence of witnesses. Search was made at the place in presence of apprehended person, and police party and found (i) Twenty (20) bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle kept in a jute bag. Being asked the apprehended person disclosed his identity as Barun Maity, age 42 yrs s/o Pashupati Maity of Rajhat, PO- Haridaspur, P.S.- Tamluk, Dist- Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and carry such country spirit. I seized (i) Twenty (20) bottles of country spirit and each bottle containing 600 ml. and cost of Rs. 65/- per bottle kept in a jute bag after preparing proper seizure list duly signed by witnesses and as well as the apprehended person. I took sample one bottle country spirit from seized article and labeled it also. I arrested the apprehend person Barun Maity, issued memo of arrest and informed him ground of arrest. During local enquiry it is clear that Barun Maity illegally posses and carry country spirit.


